Welcome to the February newsletter.

February is a very busy time in schools. We are finishing off SQA courses with our Senior Phase pupils and our S5/6 had their final assessment block prior to their SQA exams. We have the start of various practical based projects such as Music practical exams and Modern Languages orals.

February is also a time when we start to prepare for the following academic session. There are important course choice events for S2 pupils who reduce their curriculum and opt for nine subjects in S3. Our S3 pupils select their National Qualifications for S4 and decide whether to opt for two-year pathways towards H Grade or one year pathways towards National 4 or National 5 or some combination of one and two year pathways. A small number of S4 pupils re-select if they have one- year pathways whilst all S5 pupils select their S6 academic programme. These decisions, based upon the content of reports and a variety of other factors such as possible future careers aspirations are very important ones. Our guidance staff interview all pupils regarding their course choice and discuss matters in detail. Pupils and parents/carers can also access the careers service for advice if required. Based upon the course choice returns we start to devise our school timetable for 2023-

The timetable must have appropriate staffing and so the school engages with East Dunbartonshire Council over our staffing requirements for the next academic year and this is an ongoing process through until May 2023.

Every year we have a number of probationary teachers (NQTs) who join us for the year and February is when they can start to apply for positions in other schools. We support them throughout the session in various ways and I always run a couple of sessions to inform the NQTs about the application process for posts within EDC and other schools across the country and another session on how to prepare for interviews.

In the S5/6 Assessment Block, most pupils have done well. There are areas where some need to improve of course and we still have time for comprehensive revision within classes. We operate a double period study block on a Tuesday afternoon where pupils can opt for general private study or subject specific study, where we can timetable this. In addition, we are offering after school supported study in most subject areas for S4-6 students and we will offer an Easter school programme too.

We had two parental consultation meetings in February. Our S1 parents meeting had an 87% turnout rate, whilst our S3 parents meeting had a 78% attendance rate. In both cases, all parents / carers were delighted to be able to come into school and engage with their children's teachers once again. Over the past year, we have asked parents / carers whether face-to-face meetings or virtual meetings would be preferred and about 90% of parents/carers across all year groups prefer the face-to-face meetings so we will continue with this approach going forward.

One final issue to bring to your attention before you enjoy the content of the February newsletter relates to the issues that all secondary schools seem to be facing now. This relates to young people using vapes. You may be aware that a recent investigation by Trading Standards has shown that many vapes have content considered dangerous and there has been a surge in illicit sales by specialist shops and convenience stores. In North East of England, Trading Standards officers seized 1.4 tonnes of illegal vapes in a six-month period from July to December 2022. It is a significant and ongoing concern for society more widely but schools in particular. As a school, we have been pro-active on this issue and amended our PSE programme to cover this issue with all year groups and provide the pupils with the facts. We have attached below a useful link from a New Zealand parental website, although the law on vaping is for NZ it is a very informative site to help you as parents / carers to engage meaningfully with your children on this issue:

Wider Achievement in the Senior Phase



A number of pupils in S4 began their Youth Achievement award journey during Study leave by focussing on the "Challenge" - Developing my skills in learning life and work. They individually identified personal targets which they then worked on in school with Caroline Shirreffs our youth development worker, Mrs Davidson the PT of Wider Achievement and Ms Byres the PT of Developing the Young Workforce and independently at home. Once they have achieved the 31-hour award they will have the option to progress onto the two challenges of the Bronze Youth Achievement Award (SCQF level 4). There will be further opportunities to work on these challenges in May.

A group of experienced volunteers in S6 are piloting the Silver Youth Achievement Award (SCQF5) this year to give them a chance of further accreditation for their volunteering activity. They are required to identify four Challenges in which they have taken some responsibility and will have to spend 90 hours in total activity. This group is already on the ascent part of their Saltire Awards having volunteered for more than 50 hours in previous years.





A group of S5 pupils have begun their Platinum Youth Achievement Award in January having all turned 16 prior to this. The Platinum Award is a SCQF level 7 and requires five distinct and complex challenges. These are to complete a Personal Development Plan (detailing their prior knowledge and skills, their short- and long-term goals and identifying their targets for personal development as leaders of other young people), 30 hours of training, 60 hours of placement, evaluation and a presentation in front

of an invited audience. All the S5 pupils are already involved in leadership roles in the Lenzie community whether in Sports coaching or Uniformed organisations and are also on the ascent part of their Saltire Awards.

All senior phase pupils have been asked to complete a form to identify where they are volunteering in school or the wider community in their year team in order for LACE (Lenzie Academy Community Engagement) to organise Saltire Award certificates. These can be for 10, 25, 50, 100, 200 or 500 hours. Those pupils who have achieved over 200 hours can apply to be nominated for a Saltire Summit Award by LACE if they contact Mrs Davidson.

What is Fairtrade?

- R
- Fairtrade is a system of certification that aims to ensure a set of standards are met in the production and supply of a product or ingredient
- For farmers and workers, Fairtrade means workers' rights, safer working conditions and fairer pay
- For shoppers it means high quality, ethically produced products

Why is Lenzie a Fairtrade Town?

- Lenzie was named a Fairtrade Town for its work in ensuring that those in developing countries are paid a fair price for their products.
- Lenzie achieved this through raising awareness, supporting worker rights, showing its dedication to change and inspiring other communities to make a difference.
- It is also in keeping with the Fairtrade Zone that was awarded to the wider area of East Dunbartonshire in 2007.

Fairtrade Coffee

- Around 125 million people worldwide are dependent on our coffee consumption
- People tend to want quality but prefer cheaper products;
 Fairtrade offers both
- Fairtrade supports farmers and takes care of the environment
- Coffee is an unstable industry due to its reliance on climate and healthy crops without pests and diseases


Geography Trip

On Friday 17th and Wednesday 22nd February S3 Geography pupils went on a trip around Glasgow to conduct field research. We travelled by coach to 3 different locations around Glasgow visiting the City Centre, Gorbals and Bishopbriggs. Pupils have completed their urban topic in class where they have learned all about the development of a city and how to recognise urban areas so completed a variety of different field techniques in each area to consolidate their learning, including traffic counts; pedestrian counts; and land-use surveys. Following this trip, S3 pupils have been working hard in class to complete their own urban investigation by processing their data from the trip into a variety of graphs and analysing their results to combine all their learning into a final poster. "It was a fun day... especially lunch at Silverburn!"

New initiatives/information

We continue to work on additional ways in which we can offer supports to pupils.

Parental surveys will be group called out to all parents and pupil surveys posted to all year group Teams pages on Monday 20th March. This survey aims to gather your views on how successfully we are tackling pupil equity, including the financial costs associated with school and to consult with you on how we can better support the financial wellbeing of our families. Please encourage your child to complete this survey as this will also help us to understand the pupil perspective and consider ways in which we can better support our pupils. All responses will inform our practice going forward. The deadline for returning both the parental and pupil surveys is Monday 27th March.

Our school canteen will now offer a daily breakfast service which will be open to all pupils and staff. Pupils can purchase cereal, toast and juice. This is a safe, warm, comfortable space where pupils and staff can gather in the morning and purchase something to eat.

Within the school, we now have the facility to refer families in need of food support to EDC Foodbanks. EDC Foodbanks have facilities across East Dunbartonshire and provide families with food and household items, including fresh fruit and vegetables when available. If you are in need of any food support, please contact your child's Guidance Teacher in the first instance in order to start the referral process.

Information has been issued to all pupils in PSE and at assemblies regarding the Free Bus Travel Pass provided by the Scottish Government for all young people under age 22. We are encouraging all pupils to apply for this pass as it allows them to travel on all public transport buses in Scotland free of charge. For those under the age of 16, parents/guardians must apply for this pass, those over the age of 16 can apply themselves. Any pupil over the age of 16 should speak to their Guidance Teacher or Miss Provan if they need any support completing this application. All pupils complete a Wellbeing Questionnaire every year. All year groups have now completed this. The questionnaire gives us an insight into pupil wellbeing in the school and informs pupil wellbeing groups run by the Support for Pupils department.

Pupil Equity Funding Background

Pupil Equity Funding (PEF) is additional funding from the Scottish Government allocated directly to schools and targeted at closing the attainment gap. This funding aims to ensure that all young people have equal access to educational opportunities. Funding can be used at the discretion of the school to provide targeted support for young people within the Broad General Education (S1-S3) who are living in SIMD areas 1-4.

The Scottish Index of Multiple Deprivation (SIMD) is a tool the Scottish Government use to identify the geographical areas in Scotland where people are most likely to experience disadvantage across different aspects of their lives including income, employment, health, education, access to services,

crime and housing. It is important to note that SIMD ranking is based on geographical postcode and thus identifies deprived areas, not people.

Lenzie Academy has used some of this additional funding to purchase uniform items, stationery/organisational materials and hygiene products. There is a QR code outside of the upper and lower offices in the school. Pupils can scan this code and it will that take them to a Microsoft Form that they can complete if they require any of these materials. Alternatively, pupils can request this support directly from their Guidance Teacher. Materials will then be issued discreetly to pupils where appropriate. Whilst these materials are primarily there for S1-S3 pupils living in SIMD areas 1-4, we appreciate the current economic climate is challenging for many families. Your child should speak to their Guidance Teacher in the first instance if any additional supports are required and we will try to accommodate this where possible. Parents can also make contact with the Guidance teacher to discuss potential supports.

Applications for Free School Meals & School Clothing Grants

Applications for Free School Meals & School Clothing Grants for academic year 2022-23 are now open. East Dunbartonshire Council has been allocated additional monies from the Scottish Government which means they have been able to double the School Clothing Grant to £300 per eligible secondary school child. This increase is aimed at helping families cope with the current cost of living increase and will be applicable only for the current academic year. Please note, the application form can be completed and submitted at any point throughout the academic year. Pupil Equity and Financial Support for Families

In Lenzie Academy, we are wholly committed to supporting our pupils and the wider school community. This is particularly important right now given the cost of living

crisis. As a result of this, many families are experiencing financial hardship for the first time, and financial circumstances remain tough for many, even as we approach the spring.

Within the school, we have a range of resource items available to pupils. These items include school uniforms, revision materials and hygiene products. Pupils should complete the Glow form using the QR code outside the upper and lower offices to request any items that are needed, or speak to their

Guidance Teacher. Additionally, we are now registered as a referral agency with East Dunbartonshire Foodbanks. If you are in need of food support, please contact your child's Guidance Teacher and we can arrange for you to be referred to your local food bank.

Pupils eligible for a School Clothing Grant will receive a payment of £150 to help with the cost of uniform. Pupils eligible for Free School Meals will be given a daily allowance (enough to purchase one full meal at lunchtime).

Applications for the 2022/23 school year should open during July.

Education Maintenance Allowance (EMA) –

Scottish Child Payment - https://www.mygov.scot/scottish-child-payment

Scottish Child Payment is a weekly payment of £20 made to families on low incomes in Scotland who have children under 6 years of age. This can help towards the cost of supporting your family to be spent however you see fit.

Scottish Welfare Fund - https://www.mygov.scot/scottish-welfare-fund

The Scottish Welfare Fund helps families and people in Scotland who are on low incomes with living costs. Support can be provided in the format of a crisis grant, self-isolation support grant or community care grant. You must be 16 or order and on a low income, or getting certain benefits, to apply for these grants.

Child Disability Payment - https://www.mygov.scot/child-disability-payment

Child Disability Payment provides support for the extra costs that a disabled child might have. You can also apply for Child Disability Payment if the disabled child does not have a diagnosis. This payment will be paid until the child is 18. The amount of the payment can vary dependent on circumstances. The rate of payment made is dependent on the level of need of the child.

Child Winter Heating Assistance – https://www.mygov.scot/child-winter-heating-assistance

Child Winter Heating Assistance was introduced by the Scottish Government. It is a payment to help disabled children and young people and their families with increased heating costs over the winter if they are in receipt of a qualifying benefit. It is paid once a year, usually from the end of November onwards. The payment for winter 2022-23 is £214.10.

Cold Weather Payment - https://www.gov.uk/cold-weather-payment

Cold Weather Payments will be made when the temperature in your area is either recorded as, or forecast to be, an average of zero degrees Celsius or below over 7 consecutive days. You must be in receipt of certain benefits to be eligible for a cold weather payment. You'll receive £25 for each 7 day period of very cold weather between 1 November and 31 March.

Discretionary Housing Payment (DHP) -

DHP can help if your rent isn't covered by your Housing Benefit or Universal Credit. DHP awards reflect the individual circumstances of each claimant and the amount of funds available at the time of the application.

Employment and Support Allowance (ESA) - https://www.gov.uk/employment-support-allowance

ESA is a benefit for adults whose ability to work is limited through ill health or disability. You can apply if you're employed, self-employed or unemployed. ESA awards very dependent on whether the claimant is able to get back into work in the future or not.

Carer's Allowance - https://www.gov.uk/carers-allowance

Carer's Allowance is a benefit paid to people who spend at least 35 hours per week caring for someone – the person you care for must be in receipt of certain benefits for you to qualify for entitlement. Carer's Allowance is paid at a rate of £69.70 a week.

Carer's Allowance Supplement – https://www.mygov.scot/carers-allowance-supplement

Carer's Allowance Supplement is an extra payment for people in Scotland who are in receipt of Carer's Allowance at certain times of the year. The next round of payment is £245.70 in December 2022 – you'll be entitled to this payment if you are in receipt of Carer's Allowance on 10 October 2022.

Young Carer Grant - https://www.mygov.scot/young-carer-grant

Young Carer Grant is available to young people aged 16-18 who have been caring for 1, 2 or 3 people for an average of 16 hours a week for at least the last 3 months. Young Carer Grant is a yearly payment of £326.65.

Best Start Grant and Best Start Foods – https://www.mygov.scot/best-start-grant-best-start-foods

Best Start Grant and Best Start Foods are payments that help towards the cost of being pregnant or looking after a child. Best Start Grant is made up of 3 one-off payments: pregnancy and baby payment, early learning payment and school age payment. Best Start Food is a prepaid card that can be used in shops or online to buy healthy foods like milk or fruit.

Independent Living Fund Scotland Transition - https://www.mygov.scot/independent-living-fund

Young people aged 15-25 with a disability or impairment can apply to the Transition Fund for money to help them take part in a new activity or learn a new skill. The most amount of money you can apply for is £4,000.

Job Start Payment – https://www.mygov.scot/job-start-payment

Job Star Payments help with the costs of starting a new job. Young people or care leavers who have been out of work and/or in receipt of certain benefits. If your application is successful you'll get £267.65, or a higher payment of £428.25 if you're the main carer of any children.

The Scottish Government now provide a free bus travel pass to all young people in Scotland under the age of 22. This pass allows young people to travel on all public transport buses in Scotland free of charge. For those
under the age of 16, parents/guardians must apply for this pass, those over the age of 16 can apply themselves
